## UNDERGRADUATES FOCUS ON SCHOLARSHIP, ATHLETICS AND PHILANTHROPY

Tau chapter of Delta Tau Delta continues to excel in scholarship, athletics and philanthropy at Penn State. In addition, many renovations and improvements have been made to the Delt Shelter over the last year, and plans are currently being made for future improvements.

The Penn State Delts once again had a stellar academic performance during the spring semester 1998. Tau chapter's average GPA was significantly higher than the all-men's average, and we were highly ranked among the other fraternities at Penn State. This is the fourth semester in a row that we beat the all-men's average, and I am confident that we will continue to do so in the semesters to come. Athletics continue to be a strong point for Tau chapter. We finished second overall of the 54 fraternities that compete in intramural sports. This is a drop from our previous year's ranking of number one, so we are working hard to regain the number one position.

Dance Marathon takes place in February, and Tau chapter, along with Chi Omega sorority, is out in full force raising money for it. We raised \$40,000 last year and hope to surpass that amount this year.

## BEQUESTS IMPORTANT TO TAU CHAPTER

Brothers who have included Tau chapter of Delta Tau Delta in their estate plans have made a thoughtful gesture toward the fraternity and have established a method for supporting the organization in the future.

Tau chapter of Delta Tau Delta can't provide legal counsel, advanced technical support, complicated trust agreements or a thorough knowledge of tax laws like our alma mater; we can, however, promote the idea that a simple bequest — putting Tau chapter of Delta Tau Delta in your will is a method of supporting the fraternity in a significant way.

For example, did you know that Tau chapter of Delta Tau Delta can be included in your will with only a minimal amount of wording? All that is necessary is that the language include the correct legal name and address of the fraternity.

A simple example of an outright bequest would be: "I give, devise, and bequeath to Tau Chapter of Delta Tau Delta Fraternity located in State College, Pennsylvania, the sum of \_\_\_\_\_ dollars (or, \_\_\_\_ percent of my estate) (to be used for general purposes, to establish a scholarship, for house renovations, etc.)"

A portion of your residuary estate whatever is left after specific bequests have been paid — can also be designated to Tau chapter of Delta Tau Delta. Sample wording to do this would be: "All the rest, residue, and remainder of my estate, both real and personal property of whatever and wheresoever situated, which I may own or have the right to dispose of at the time of my death, I give, devise, and bequeath to Tau Chapter of Delta Tau Delta Fraternity, located in State College, Pennsylvania, (to be used for \_\_\_\_\_\_)."

Using this sample language can greatly reduce the potential for legal disputes during probate. This language can be shared with your attorney should you be interested in providing for Tau chapter of Delta Tau Delta in your estate plans.

We encourage you to contact us if you have any questions. And, of course, it is important that you consult with your attorney or financial adviser.

To those of you who have already provided for Tau chapter of Delta Tau Delta in your estate plans, you have made a very important commitment to your fraternity. We appreciate your generosity.


# HOUSE IMPROVEMENTS LIFT SPIRITS OF TAU CHAPTER
