As many of you know, John served the fraternity loyally for over 35 years. John first volunteered as a general board member and then served as treasurer for over 20 years. John supported Tau loyally through some very difficult times, including the loss of the Chapter in the late 1960s and the fire that destroyed the Shelter in 1980.

Through it all John maintained a sense of optimism and hope and gave the board the fiduciary discipline and wisdom to ensure a future for Tau. Our thoughts and prayers go out to John's wife Anita and his daughter Christina Glise Alt. All of us will miss John and his commitment to excellence, his business sense and most importantly, his friendship.

John Edward Glise of Camp Hill, president of John Glise Realtor Inc., died on Monday, [September 20, 2000] at his home. He was a member of Paxton Presbyterian Church, a graduate of Penn State University and member and treasurer of Delta Tau Delta Fraternity, Penn State Alumni Association, Nittany Lion Club, West Shore Country Club, Greater Harrisburg Association of Realtors, Pennsylvania Association of Realtors, National Association of Realtors, Home Builders Associa-

tion of Metropolitan Harrisburg and a board member of the Central Penn Multi List Association. He was also a former Republican state committeeman.

Bill Rothman, a realtor and partner at Rothman, Schubert and Reed, noted that Glise was "a very upbeat guy until the end. He was a very good realtor, a good businessman."

"He was also a housing development consultant and did a very commendable job," Rothman said. "I am sure that he went without any enemies."

Chuck Gilmore, vice president of John Glise Realty, said, "John and I were partners for almost 20 years. I think from the perspective of the real estate community, John was certainly an important part of it and a friend of the community. He was a respected leader by anyone who knew him in the business community. John was a great guy to work with. When you work with someone for 29 years, it takes an easygoing person to do that, and to be in it for 30 years says something about his professionalism."

Mike Ent, a good friend of Glise and an associate broker with RE/MAX Realty Association of Camp Hill, said Glise was an innovator.

“Back in the late '70s, before the public was familiar with home warranties, John affiliated with Palace Guard Homes, who covered the mechanical components of the property for one year. This was something new to our area,” Ent said.

Glise was the man who taught Ent the business fundamentals.

“He was a mentor to many agents who are now in their late 40s and early 50s. He had a terrific sense of humor in any situation. If we had a difficult transaction, he could always see the humor and use it to our advantage. I started with him in 1973 and was among his first agents. The biggest thing he stressed was that it was a service business, and we weren't necessarily selling homes, we were selling ourselves.”

Surviving are his wife, Anita Ricento Glise; a daughter, Christina Glise Alt of Philadelphia; a foster daughter, Susan Kent Allison of Lancaster; his parents, the Rev. Morton and Martha Glise of Harrisburg; and a sister, Harriet Epler of Harrisburg.
