Capital Campaign Update

YOUR SUPPORT MAKES RENOVATIONS HAPPEN

Since the introduction of the Strengthening the Bond capital campaign in summer 2003, 175 Tau alumni have pledged close to \$350,000 in total cash donations to the Chapter. We are pleased to report that, as of the end of the year, close to \$210,000 in payments toward pledges have been received. Our numbers of late for missing pledge payments is about three percent of the total outstanding — which is very good, according to the staff at Affinity Connection.

Still, if you are behind on your commitment, please catch up as soon as possible. We are counting on your support.

In addition to the cash pledges, over \$100,000 in pledges have been made in planned-giving commitments. So, in total, the campaign has raised over \$450,000 for the Chapter. With these funds in hand, along with a mortgage from the Delta Tau Delta Educational Foundation, the Tau Company has been investing in the Shelter.

As noted in the alumni president's update, great progress has been made in refurbishing the second- and third-floor bathrooms, hallways and doors. The Tau Company is now turning its attention to the first floor of the Shelter, which is very tired and has an "institutional" look and feel. Our plans are to make some changes to better use the floor space and to give the area a warmer look and feel as we refurbish the first floor. This area has not been updated since the reconstruction from the fire in 1980.

As the Strengthening the Bond campaign continues, there is still the opportunity for an individual or class to name the Chapter room or dining room in return for an especially significant contribution. If you are interested in discussing a naming opportunity or in organizing a class gift with naming rights, please contact Jim King '78 or Tim Phillips '79 by phone or e-mail.

RECENT SUCCESS IN RECRUITMENT AND SCHOLARSHIP INCLUDES 16 NEW MEMBERS AND SOLID 6TH GPA RANKING



Tau Company Financial Update

As of December 31, 2005, Tau Company had \$180,080 in cash on hand. Subtracting the current repair expense of \$65,000 and the amount due to DTD International in 2006 (\$39,600, or \$3,300 per month over 12 months) leaves us with an estimated 2006 working capital of \$75,480.

The \$65,000 in repairs covers the work done in reconstructing the third-floor bathroom and renovating the third-floor hallway, which included new ceiling tiles, wainscoting and carpeting.

Work is underway on the first-floor men's bathroom, and we are looking forward to finally beginning renovations on the ceilings in the foyer and Chapter room later this year.
