Letter From the President

Shelter Reaches Maximum Occupancy & Record Undergrad Numbers as We Embark on Critical Upgrades!

Wow! I am excited about what is happening with the Actives who are taking care of the Shelter and carrying on the Delt tradition! As you can see in the State of the Chapter section below, there are quite a few impressive Brothers who have fully embraced their executive roles and are making great progress with recruitment of future Delts, budget management, and caring for the Shelter.

On Saturday April 18, 2015, the Board held their annual spring meeting the morning of the Blue-White game. The meeting was well attended. *I am proud to announce the appointment of two new "old" members to the Board. Heeding the call and offering to assist, Brother Jim King '79 and Brother Bill Fustos '79 have graciously agreed to rejoin the Board.* Jim is a past Tau Company and Alumni Board President, and Bill is a past Alumni Board member. Please join me in thanking them for stepping up!

During the Board meeting, one of the most exciting items reported by the Actives is that for Fall 2015, there will be 47 Brothers living in the house, an all-time high! There is actually a demand for more to move in, but the Shelter cannot legally or comfortably support more than 47 Brothers. It is also anticipated that there will be 40 Brothers living in the Shelter for Spring 2016. The Brothers also won Greek Sing this year, led by President Martino Parente, and apparently are quite the success with intramural football. All good stuff indeed. The quality of the Actives' executive team was impressive, and their attitude and resolve to be the best is also commendable.

There was also discussion about a recent targeted donation for more Shelter improvements. If you will recall, Mr. David Musto, a Delt from RPI's Upsilon chapter and whose son is a Brother of Tau Chapter, had donated funds earmarked for the purchase and installation of our new dishwasher last fall. We had some funds left over and will use those remaining funds to purchase and install a new kitchen exhaust hood system. This kitchen hood is something we have needed to replace for over four years, and *we thank Mr. Musto for his very generous support*! In keeping with his request that we use the donation for internal Shelter improvements, we also plan to purchase some new furniture for the Shelter, which is badly needed.

Also discussed at the meeting was the *condition of the exterior masonry façade of the Shelter*. Recalling my last *Tau Tales* President's Report, we are moving forward with the necessary paperwork to obtain a loan from National to help us pay for the badly needed masonry structural repairs. We will be borrowing a minimum of \$100,000. We had commissioned a detailed masonry survey last fall and are now in the position to complete the loan documentation. We are obtaining additional competitive prices for the work using a scope of work developed and based on the referenced survey. *It's our hope that the work will be completed this summer*.

With the addition of two new Board members, *I am sad to report the departure*

of Brother Phil Lucas '82 from the Board. We thank Phil for his many years of service! With Phil's departure comes a Board vacancy. If you are interested in giving back to Tau Chapter, please contact me at 717-522-1432 or jthorsen@aol. com.

HE MAY NOT BE A TAU DELT, BUT HE IS AN AWARD-WINNING ALUM GIVING HIS TIME TO DEVELOP OUR NEXT GENERATIONS OF BROTHERS



"If you're lucky enough to do well, it's your responsibility to send the elevator back down." This quote from award-winning actor Kevin Spacey is a reminder of the obligation we all have to turn our own personal successes into opportunities to share our experience and wisdom with those still finding their way. One of our fellow Delt Brothers who has been sending the elevator back down year after year is Tau Chapter Advisor **Todd Lewis**, a 1961 University

of Minnesota graduate and former Chapter President of Beta Eta Chapter. Todd was named Advisor of the Year for the Delta Tau Delta Eastern Division during the annual division conference held in Morristown, NJ, in February.

From 1961 until his retirement in 2001, Todd maintained a successful career in sales and marketing management, including 36 years with Armstrong World Industries. Todd and his wife, Martha, had found a permanent home in Lancaster, PA, where they had raised their son and daughter and were now enjoying their grandchildren. It was time to start giving back to his community and to one institution that had been helpful in Todd's success — Delta Tau Delta.

In 2010, Todd responded to an email from the National office asking for chapter advisors in and around the Lancaster, PA, area. He was immediately assigned to Penn State — a two-hour drive one way. He decided to give it one year. Now five years later, he remains very involved with the Tau Chapter as their advisor.

"Our undergraduate officers are like small business managers of a very diverse company with 100-plus employees. At Tau Chapter, these young men are responsible for \$500,000 in cash flow each year. This is a real business they are running ... "

"My family will ask me occasionally why I keep doing this," he said. "I get to see the new incoming freshmen when they are pledged. I talk to them when they first come in. After they complete one year as an officer or committee chair, I can see that they have matured into men right before our eyes. It is very rewarding to see this happen. Our undergraduate officers are like small business managers of a very diverse company with 100-plus employees. At Tau Chapter, these young men are responsible for \$500,000 in cash flow each year. This is a real business they are running where they may have to confront some of their best friends about conduct and discipline. This turns an 18-year-old boy into a man in a hurry."

Todd feels privileged to have witnessed first-hand the growth of Tau Chapter into one of the largest at Penn State with an impressive presence on campus. "Our GPA of 3.19 puts us in a top tier among fraternities and considerably above the all-male average. We have the highest GPA of all 14 PSU fraternities with 100 or more men. I think that is an accomplishment. They have been able to balance academics with their participation in IM sports, THON, other philanthropies, and their leadership roles on the IFC and in other organizations."

The real success, as Todd explains, is the ability of younger officers to meet the increased demands and expectations that are part of the Greek culture and experience today. "I was a chapter president as a senior at age 21. My only real responsibility was keeping the guys in line. The pressure of today's chapter leadership, usually sophomores at age 19/20, is excruciating compared to what I had to do. For example, today's president is responsible for a 100-page annual report to National and the university; a \$500,000 budget; the negotiation of legal contracts with vendors; relationships with the local municipality, law enforcement, parents, and Alumni; and the care of a multimilliondollar property — all while being a student and trying to have a little fun. All of this requires help from those with life and business experience — a mentor, coach, counselor, and cheerleader. I am happy to play that role and to do everything I can to build them up as individuals and as Brothers. It is my turn to give something back and help them be productive members of society."

TAU CORPORATION BOARD TO SECURE FINANCING FOR CRITICAL SHELTER REPAIRS

Financially speaking, Tau Corporation has completed another academic year. We have been able to successfully operate, maintain, and repair the Shelter, but with only relatively modest improvements planned for this summer in preparation for our record number of Brothers in the fall.

One planned improvement is a longoverdue restoration of the 35-year-old wooden floors on the first floor — a fairly expensive undertaking. The floors will be professionally
